Petitioner filed his third Petition for Habeas relief on May 22, 2002. That Petition was denied on May 28, 2002. He has now filed two additional Petitions contending the Court was confused and not paying attention to previous contentions. These fourth and fifth Petitions are also DENIED.

The issues were previously addressed and decided and will not be considered again. *In re Horowitz*, 33 C2 534. Additionally, petitioner is not entitled to continue filing additional Petitions that concern contentions previously raised or which could have been previously raised. All such grounds are to be included in one single and first Petition. *in re Clark*, 5 C4 750.


